### SafeHouse Center's Mission

SafeHouse Center is a 501(c)(3) non-profit organization whose mission is to provide safety, support, advocacy, and resources for survivors of sexual assault and domestic violence and their children, and to work relentlessly to change the systems and attitudes that allow this abuse to continue.

### **Core Values**

Having the ability to offer emergency and temporary shelter to survivors fleeing a harmful situation is crucial. However, we also work diligently through our non-residential programs to allow survivors to remain safe in their own homes and not suffer displacement by engaging in safety planning, Personal Protection Order applications and general advocacy. Survivors sometimes have unique challenges, and we continue to provide the best support that we can with the resources we have available to us.

As we look towards the future, we have also been resuming our activity in the community by seeking to reconnect and/or foster new and intentional community relationships with service partners and members. Please know that I am available to listen because there is power in unity, and I believe it important to be seen as a productive and collaborative community partner. I look forward to working with you.

## SafeHouse Center's Programs & Services

All SHC services are free, confidential and promote empowerment, autonomy and safety.

### **Crisis Support**

SafeHouse Center offers individual, short-term, crisis support to any survivor of domestic violence or sexual assault. Crisis support sessions provide survivors with a supportive environment to process their experience, engage in safety planning and explore resources.

### **Emergency Temporary Shelter**

Our emergency temporary shelter is available to survivors of domestic violence and sexual assault who are fleeing a harmful situation. Our shelter is a safe and welcoming home where survivors can take steps towards reclaiming their independence and also access all other SHC services including general advocacy and resource sharing.

### Legal Advocacy Services

SafeHouse's Legal Advocates provide informational and emotional support to survivors of domestic violence and sexual assault as they engage with the criminal or civil legal system.

Legal Advocates do not act as attorneys for survivors and are not able to provide legal advice or representation. However, they are available to survivors to discuss their legal rights, the legal process, possible outcomes and to provide information that will help survivors make informed decisions about whether and how to engage in the judicial process. Legal Advocates also provide assistance with the filing of Personal Protection Orders and may also be available for court accompaniment to all court hearings within Washtenaw County.

## SafeHouse Center's Programs & Services (cont.)

#### The Response Team

Established in 1987, The Response Team (RT) at SafeHouse Center provides 24 hours a day, 365 days a year immediate response to survivors of domestic violence and/or sexual assault.

All Washtenaw County law enforcement agencies contact RT after receiving a report of domestic violence and/or sexual assault. Local area hospitals also contact RT when a patient discloses that they have experienced domestic violence and/or sexual assault. SafeHouse staff or volunteers then make contact with the survivor either in person or by phone to offer support and information and to help plan for their safety.

The RT contact is often the first time that a survivor learns of SafeHouse, our services and the resources that are available to help and support them. This is also often the first time that the survivor may have been able to talk with someone about their situation without being blamed for the abuse and/or assault or judged for staying with their partner.

### Support Groups

Survivors of domestic violence and sexual assault often feel alone and isolated as they cope with the impact of their crisis or assault. Many survivors find it helpful to talk with others who have had similar experiences. We offer a variety of weekly support groups for survivors of domestic violence and sexual assault.

### Helpline

Survivors of domestic abuse or sexual assault, their friends, family and other concerned people can call our 24-hour Helpline to talk, get information and resources, or learn more about our services.




