Safehouse also provides legal advocacy services, support and referrals in both criminal and civil law systems.

All disbursements, including payroll, will be assigned or allocated to the appropriate grant or funding source after determining cost allowability per the contract agreement.

-The Finance Office shall prepare all billings and invoices on a timely basis. These billings will be reviewed, compared to the grant budget and signed by the Finance Director/Executive Director. Prior to mailing the
